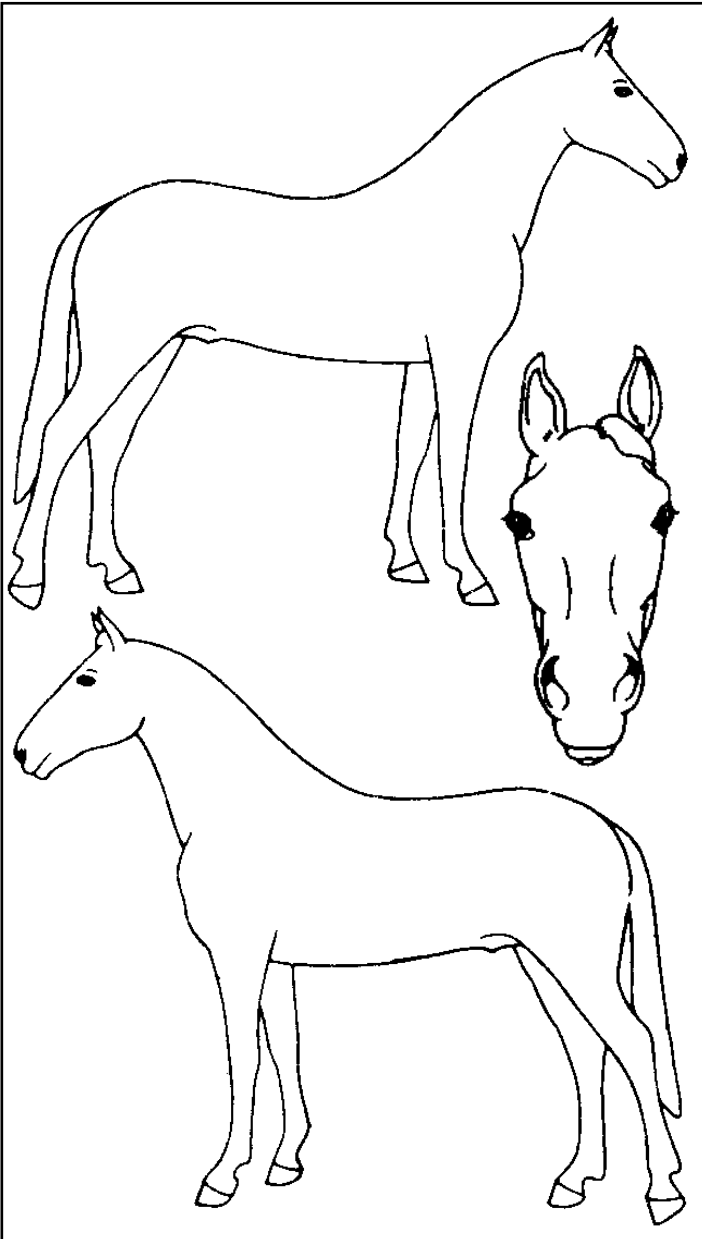

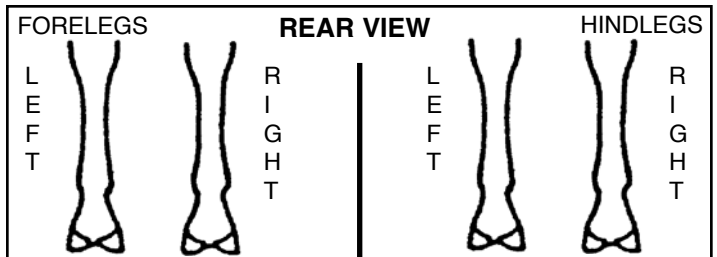
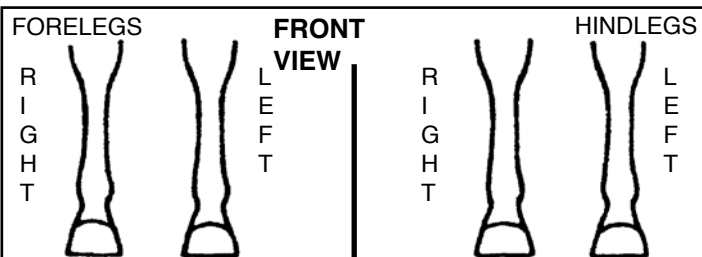

**SPECIAL CONDITIONS:**

1. Eligibility for participation in the International Jumper/Dressage Futurity, (hereinafter IJF) program is contingent upon full payment of the required nomination fee. Eligibility shall be revoked if payments are not made by required deadlines.
2. The IJF reserves the right to cancel, postpone, or change the conditions of all or any part of the IJF without liability.
3. The IJF may desire to televise, broadcast, and/or record (on film or videotape) the IJF competitions and the activities incident to them, and to broadcast, exhibit and/or exploit same by any means now or hereafter known. All nominations are accepted only on the condition that the IJF reserves the rights to advertise the IJF in any manner it deems appropriate, including the use of names and likenesses of nominated stallions and their progeny. The nominator hereby expressly and irrevocably waives and releases any rights he may have in connection with any matter referred to in this paragraph including, without limitation, any claim to the invasion of the right or privacy or to misappropriation.
4. The nominator understands and agrees that any use by him of the name, logo, or material relating to the IJF will be restricted by the IJF.
5. The IJF reserves the right to utilize the funds received from nominations in such a manner as it deems appropriate, including, without limitations, the payment of administrative and promotional costs and expenses.
6. Stallion and Young Horse nomination fees are not refundable after the nomination deadline. The nomination fee is payable and accepted with the understanding that should the event be canceled a pro-rata share of the original fee paid shall be refunded, less promotional and administrative expenses, according to the nominator's share of the total fees paid.
7. Nominations and fees paid constitute an agreement between the nominator, the IJF, and any other associated party, that should any dispute arise, it shall be decided by the IJF and its committee, whose decision shall be final and binding to all parties.
8. Anyone who knowingly falsifies the nomination information may have his eligibility revoked and may be barred from competing in any or all IJF competitions.
9. The nominations and entries are accepted upon the condition that every entry in the IJF shall constitute an agreement and affirmation that the person making it, along with the owner, trainer, manager, agent, and rider, shall:
  - a) be subject to the rules of the IJF and the local rules of the event;
  - b) that every horse or rider is eligible as entered;
  - c) that the owner and his representatives are bound by the rules of the IJF and the event, and will accept as final the decision of the IJF Executive Committee on any question arising under said rules and agree to hold the show, the IJF, and its officials, directors, and employees harmless for any action taken;
  - d) that the owner, rider, and any of their representatives agree to hold the IJF, the show, officials, directors, employees, and agents harmless for any injury or loss suffered during or in connection with the IJF, whether or not such injury or loss results, directly or indirectly, from negligent acts or omissions of said officials, directors, employees, or agents of the IJF or the show. The construction or application of these rules are governed by the laws of the State of California.

The International Jumper Futurity is a non-profit 501(c) 5, non-stock corporation organized under the laws of the State of California.



## International Dressage Futurity Program Guidelines

### Competitions

The International Dressage Futurity will be based on scores earned in the FEI or USEF 4-year-old test at USDF/USEF recognized dressage competitions. Every IJF and IDF nominated 4 year old horse is eligible for entry. Scores may be earned in FEI or USEF Young Horse classes or via a test-of-choice format. Scores should be submitted to the IJF office immediately following the competition: PO Box 1445, Georgetown, KY 40324.

Four Year Old Dressage Program-open only to IJF and IDF Nominated 4 year olds.

- A horse's participation in other dressage events will not effect his/her eligibility.
- Prize money is generated through the nomination fees from stallions and young horses. Each horse entered in the 4YO competition will receive prize money based on the average of their two best scores:  
\$750 for 6.5 to 7.5; \$1,000 for 7.6 to 8.4; and \$1,500 for 8.5 or above. In addition,  
\$100 will be paid to the original nominator of the horse and \$200 to the stallion nominator for every off spring by the stallion completing the test with a qualifying score of 6.5 or above.

### Dressage Bonus Awards and 5 and 6-Year-Old Programs

All nominated horses are encouraged to enter Young Jumper Championship or Young Dressage Horse Championship competitions. Additional Bonus Prize money will be paid to the top IDF nominated horses in the Young Dressage Horse Championships.

# International Jumper Futurity

## Program Guidelines

### Competitions

Three competitions will be held each year. Every IJF nominated 4 year old horse is eligible for entry in one competition. Each event will be held in conjunction with a major jumper show. Every effort will be made to schedule the IJF competitions to assure the greatest possible exposure for these horses. Every IJF nominated horse will also be eligible to compete in all Young Jumper Championship competitions with no additional nomination fees required.

### Competition Entries and Drug Testing

IJF entry forms will be mailed to all 4 year old owners approximately 2 months prior to the competitions. All entrants must contact the horse show hosting the IJF event for stabling and drug forms prior to the show's closing dates. The IJF may conduct drug testing for forbidden substances in conjunction with, or in accordance to USEF testing.

### Four Year Old Program-open only to IJF Nominated 4 year olds.

- To be eligible to compete, 4 year olds must never have entered or competed in any jumper event with fences exceeding 3'9" in height.
- A horse's participation in hunter events will not effect his/her eligibility.
- Each horse entered in this year's competition who completes both rounds will receive \$1000. Trophies and additional prize money will be given for three categories. Breeders awards of \$200 will be given to each stallion nominator. The original young horse nominators will receive \$100.
- Participating in the IJF events will not, in itself, jeopardize a horse's First Year Green eligibility.

### IJF Bonus Awards in Young Jumper Championships 5, 6 and 7/8 Year-Old Programs

All nominated IJF horses are encouraged to enter Young Jumper Championship (YJC) competitions. Additional IJF Bonus Prize money will be paid to the top IJF horses in each final YJC League Final.
